Constitution and Governing Principles of the LFT Society



The Fifth-Dimension

Your success will depend entirely on the team you choose. Consider the person who stood by you, offering that difficult, alternative exit or path when needed. PYTHONIC CODES OF CONDUCT

□ Preamble

We, the members of the **LFT Society**, acknowledging the importance of teamwork, leadership, and strategic communication, hereby establish this constitution. The aim is to promote an effective organizational structure based on the principles outlined in the "**LFT Pythonic Code of Conduct**." This constitution defines our governance model, leadership structure, succession processes, and the fundamental duties and responsibilities of all members, ensuring the growth, development, and sustainability of the Society.

Article 1:

NAME AND PURPOSE

1. The name of the organization shall be **LFT Society**. Meaning; "we **Love to Fix Things**" (LFT).
2. The purpose of the Society is to nurture **talents** across various domains, promote **trading** (both digital and physical asset) and **unity** among members, and ensure effective coordination in the execution of **duties**.

Article 2:

LEADERSHIP STRUCTURE

- The **LFT Society** shall be governed through a **Pyramid Structure**, organized as follows:

Section 1:

THE BLOCK AND PYRAMID SYSTEM

1. **Block 1 (BLK1)**: The shield of the **1st Pyramid**, representing the President, known as the **PYRA**.
2. **Block 2 (BLK2)**: The shield of the **Vice President** and **General Secretary [Bookman] (2nd and 3rd Pyramids, respectively)**.
3. **Block 3 (BLK3)**: The shield of the **4th to 7th Pyramids**, including the **Art Coordination Director, Tech Admin, Public Mayor, and**

Monetary Auditor respectively.

4. **Block 4 (BLK4)**: The shield of the **8th to 11th Pyramids**, comprising the **Council Leader, Cinematographer, News Anchor, and UI/UX Manager** respectively.
5. **Block 5 (BLK5)**: The shield of the **12th and 13th Pyramids**, representing the **1st and 2nd Council Leaders** respectively.

Section 2:

ORDER OF POWERS

1. The **PYRA** holds ultimate authority and chairs all General Meetings.
2. In the absence of the **PYRA**, the **Vice President** assumes leadership, followed by the **Bookman** in the absence of the Vice President.
3. **The executive leadership**, known as **The Loop**, consists of the **1st, 2nd, and 3rd Pyramids**. These positions represent **eternal sovereignty** in line with their lineage.
4. Should the **PYRA**, the **Vice President**, and the **Bookman(G.M)** be unavailable, the **Council Leaders** shall assume interim leadership roles.

Article 3:

THE LOOP AND SUCCESSION

- The Loop refers to the perpetual authority vested in **Block 1 and Block 2**.

Section 1:

□ The 1st Pyramid (PYRA)

1. The first occupant of **Block 1** is the legitimate **PYRA**
2. Succession shall pass to the **PYRA's** sons, who must be **18 years** or older, under the guidance of the **Council**.
3. If no immediate lineage is available, the **Vice President** assumes the role of the **PYRA**.

Section 2:

□ The 2nd Pyramid (Vice President)

1. The **Vice President** acts as **PYRA** in their absence.
2. Succession follows a similar process to the **PYRA**, passing to the **Vice President's sons**, guided by the **Council**.

Section 3:

□ The 3rd Pyramid (Secretary or Bookman)

1. The **Bookman** acts as the Vice President in the absence of both the **PYRA** and the Vice President. **PYRA** roles therefore become the duty of not even 2.5 but all **3 council leaders**.
2. The **Secretary's** role is succeeded by **Children** aged **18 years** and above, under the guidance of the **Council**.

Article 4:

LEGISLATIVE BOARD

- Primary governing body responsible for formulating, reviewing, and approving policies, and legal frameworks that govern the LFT Society. Its mandate includes ensuring that all operations and decisions of the Society align with the LFT Pythonic Codes of Conduct and applicable legal standards.

Section 1:

□ Block 3 (4th to 7th Pyramids)

1. Block 3 represents the **Legislative Board** of the Society
2. Offices become vacant after every **2 years**.
3. Candidates for these positions must successfully pass a vetting process and secure at least 50% of votes.
4. Candidates must hold a minimum of an HND in any field and be at least 18 years old.
5. Candidates must be **Ghanaian**.

Section 2:

ELECTORAL COMMISSION BOARD

□ Block 4 (8th to 11th Pyramids)

1. Block 4 represents the **Electoral Commission Board** of the Society with the Council Leader serving as its Chairperson.
2. Offices become vacant every **2 years**, except for the **council leader**(11th Pyramid) who chairs meetings in that office.
3. Candidates are subject to the same vetting and voting process as **Block 3**.
4. Candidates must hold a minimum of an HND in any field and be at least 18 years old.

5. Candidates must be **Ghanaian**.

Article 5:

JUDICIAL POWERS (BLOCK 5)

Section 1:

12th and 13th Pyramids (Council Leaders)

1. Block 5 represents the Judicial Powers of the Society, with the council leaders serving as the governing body responsible for overseeing and administering the Society's legal and Disciplinary matters.
2. Council members must be at least 20 years old, hold a minimum of an HND, and be married.
3. Occupants of these offices are appointed by the executive leadership of the society chaired by the PYRA.

Article 6:

VETTING COMMITTEE

□ The Vetting Committee, responsible for vetting all candidates, shall consist of:

1. The *PYRA* (President)
2. The Vice President
3. The General Secretary (Bookman)

4. The Council Leaders
5. The Coordinator
6. The Public Mayor

Article 7:

AMENDMENTS AND VOTING

1. Any amendments to this constitution require the approval of at least **two-thirds** of the Society's **executive** members.
2. Voting for leadership and amendments shall be conducted via secret ballot, with a simple majority required for decisions to pass.

Article 8:

CAUTIONARY PROVISIONS

1. Offices in the Loop (1st, 2nd, and 3rd Pyramids) are only subject to voting when no suitable successors are available.
2. If any successor is not of age (under 18), the office will be temporarily managed by the Council.

Article 9:

DISSOLUTION OF THE SOCIETY

- The LFT Society may only be dissolved upon a vote with a **90%** majority of the executive members, and after all obligations and commitments had been fulfilled.

CONCLUSION

This constitution, modelled on the timeless principles outlined in the "LFT Pythonic Code of Conduct," serves as the foundation of governance for the LFT Society. Through it, we aim to ensure continuity, foster leadership, and promote success for all members and the Society.
